1. Call to Order and Announce a Quorum is Present:

- 4.** Commissioner Perrault made a motion to approve the minutes of April 8, 2019 regular meeting. Mayor Pavlock seconded the motion. Motion passed unanimously.
- 5.** Mayor Pavlock provided an update on Rosenberg Street. No action taken.
- 6.** Commissioner Perrault made a motion that the city will start paying the Code Enforcement Officer ½ of the building permits which would include all inspections as well as ½ of other permits that are pulled for various items and projects. Mayor Pavlock seconded the motion. Motion passed unanimously.
- 7.** Commissioner Perreault made a motion to accept the engagement letter from Seidel Schroeder for the 2018 audit for \$7,600.00. Mayor Pavlock seconded the motion. Motion passed unanimously.
- 8.** Mayor Pavlock suggested that we review the park policies and possibly put a limit on how many people can be there at one time. No action taken.
- 9.** The city looked at our water and sewer tapping prices compared to other local cities around us. Before coming up with a fixed price we will speak with Wes Supak. No action taken.
- 10.** Mayor Pavlock provided an update on the pavilion project. Currently waiting on the go ahead from Texas Parks and Wildlife but it looks like the city can go out for bids in June of 2019.

12. No action taken on the budget.


