AN ORDINANCE AMENDING AN ORDINANCE PASSED AND APPROVED HERETOFORE ON THE 14TH DAY OF MAY, 1975, CREATING AND SPECIFYING THE DUTIES OF THE OFFICE OF MANAGER OF UTILITIES: REQUIRING A PERMIT TO CONNECT TO THE CITY WATER SYSTEM, PROVIDING FOR INSPECTION, FEES AND CHARGES FOR WATER SERVICE, TIME OF PAYMENTS, DISCONTINUANCE OF SERVICE AND RECONNECTION REQUIREMENTS: REQUIRING A PERMIT TO CONNECT TO THE CITY SANITARY SYSTEM, PROVIDING FOR INSPECTION, FEES AND CHARGES FOR SEWER SERVICE, TIME OF PAYMENT, AND DISCONTINUANCE OF SERVICE:

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF ORCHARD, STATE OF TEXAS:

I.

That ARTICLE TWO: Water, be amended by adding Section 12 which shall read as follows:

Section 12: In order to fairly distribute the cost and expense of maintenance of the city utility system, there shall be added to the bill of each customer whose service address is outside of the city limits of Orchard a monthly service charge of \$5.00 per month per meter. Customers who receive service beyond the city limits of Orchard shall be subject to all provisions of all ordinances now in effect or hereinafter enacted pertaining to city water service.

II.

That ARTICLE THREE: Sewer, shall be amended by adding Section 12, which shall read as follows:

Section 12: No person, business, or commercial operation, the service address of which is outside the city limits of Orchard shall receive sewer service unless such person, business, or commercial operation shall also receive city water. Any recipient of city sewer service, whose service address is outside the city limits of Orchard shall in any event be subject to all provisions of all ordinances now in effect or hereinafter enacted pertaining to city sewer service.

III.

The fact that it is essential that the costs and expenses of maintenance of water and sewer service facilities be fairly borne by the recipients of such services in order that the citizens of the City of Orchard, Texas, may be provided with such water and sewer service constitutes and creates this ordinance an emergency measure being one for the preservation of the health of the citizens of the City of Orchard, Texas, and necessitating that this ordinance be adopted as an emergency measure and it is so ordained, passed, and approved.

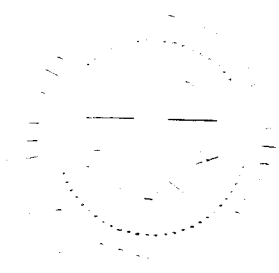

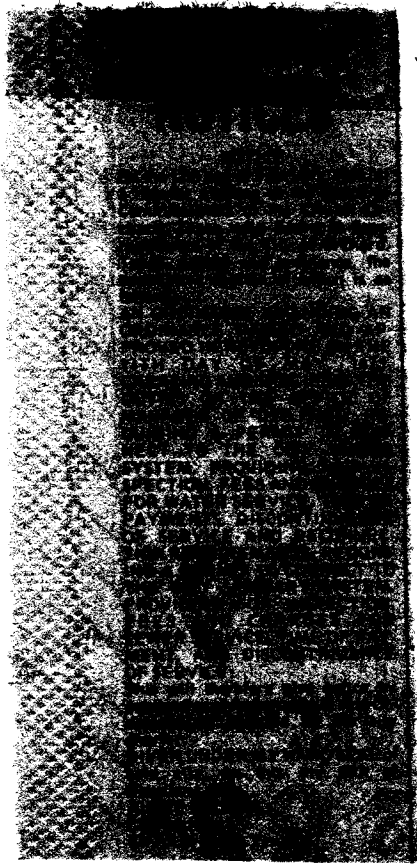
