### Fee Schedule for Ordinance No. 102-2014 Game Room Ordinance

| 1. For 1 to 5 machines    | \$100.00 per machine  |
| 2. For 6 or more machines | \$1000.00 per machine |

5 machines = \$500.00

6 machines = \$6000.00

## COMMERCIAL CERTIFICATE OF GAME ROOM OCCUPANCY APPLICATION

---

In order for the City of Orchard to issue a Certificate of Occupancy, the following must be submitted with the application and **before** the space is occupied and open for business.

- A Game Room Certificate of Occupancy inspection will need to be scheduled with the City Inspector by calling the inspection line at 979-478-6893.
- A detailed floor plan of proposed space/area must be drawn to scale. Compliance with the attached game room regulations must be shown on the plans.
- A survey must be submitted, showing scaled and dimensioned parking spaces in compliance with this ordinance.
- Permit fee: \$50.00
- Upon approval, an annual license fee shall be paid according to the following fee schedule:
  1. For 1 to 5 machines            \$100.00/machine
  2. For 6 or more machines        \$1000.00/machine
