

## Orchard City Council Regular Meeting, November 14, 2024

- 1. Call to Order and Announce a Quorum is Present: With a quorum of the Commissioners present, Mayor Matt Perreault called the Regular Meeting of the Orchard City Council to order at 5:00 p.m. on Thursday, November 14, 2024 in the Council Chambers of the Orchard City Hall, 9714 Kibler, Orchard, Texas.

- 3. Visitors / Citizens Forum: The following guests were in attendance: Lori Petisca (citizen), Tristian Gudduschatt (citizen-speaker), Banesa Montoya (EDC-speaker), Christina Lozano (EDC-speaker), Tracy Rodriguez (SafeBuilt-speaker), Brad Bond (SafeBuilt-speaker), Jack Moore (citizen-speaker), Danielle Perreault (citizen)
- 4. Commissioner Wesbrooks made a motion to approve the October 14<sup>th</sup> minutes. Commissioner Supak seconded the motion. Motion passed unanimously.
- 5. Commissioner Wesbrooks made a motion to approve the October 28<sup>th</sup> workshop minutes. Commissioner Supak seconded the motion. Motion passed unanimously.
- 6. Commissioner Supak made a motion to approve the rental of the Pavilion to Tristian Gudduschatt for a Community Praise Night on Friday, December 13, 2024 from 7:30PM 10:00PM. Commissioner Wesbrooks seconded the motion. Motion passed unanimously.
- 7. Commissioner Supak made a motion to approve the EDC Christmas Event presented by EDC. Council approved the Saturday, December 14<sup>th</sup> Judging of the Lights / Sunday, December 15<sup>th</sup> Christmas Parade and Community Celebration. Council approved EDC request of \$5,500.00 budget to purchase new Christmas Décor / Prizes / Food. Council has recommended to have quarterly meetings with EDC to go over upcoming events. Commissioner Wesbrooks seconded the motion. Motion passed unanimously.
- 8. Mayor Perreault made a motion to approve SafeBuilt as a temporary third-party Code Enforcing for the city of Orchard. Council agreed to use a "Complaint -Based" code enforcing process. Council agreed to 2 days a month, \$1360.00 per month. Council agreed to have SafeBuilt look into City Ordinances and recommend updates to them at extra cost. Council agreed to notify citizens in December by posting the upcoming code enforcing to start January 2025. This will be posted on December water bill, City of Orchard website, Facebook and posted at regular physical posting locations. Kick-Off to introduce SafeBuilt to citizens, and City of Orchard Judge. Commissioner Supak seconded the motion. Motion passed unanimously.

- 9. Commissioner Wesbrooks made a motion to approve the Ordinance 134-24, Supak Annexation. Mayor Perreault seconded the motion. Motion passed unanimously. Commissioner Supak abstained from vote.
- 10. No motion needed for CenterPoint CRR Rate Schedule. This is informational that gets filed.
- 11. Commissioner Supak made a motion to adopt the Resolution 2024-120, TikTok Policy. This was put into effect in 2023 by Governor Abbott, TikTok cannot be used on devices used for state business. Commissioner Wesbrooks seconded the motion. Motion passed unanimously.
- 12. No motion needed for Solicitors Permit for Mueller Tech Services, LLC. The Ordinance is in place for the city, however currently permits are being created to be used in conjunction with the rules of the ordinance. Solicitors may come to Orchard as long as the get permit from city hall and follow the rules.
- 13. Commissioner Wesbrooks made a motion to approve the Petition for Consent to Creation of Orchard Municipal Utility District No. 1, including adoption of Ordinance 135-24 in connection therewith. Commissioner Supak seconded the motion. Motion passed unanimously.
- 14. Commissioner Wesbrooks made a motion to approve the Petition for Consent to Creation of Orchard Management District No. 1, including adoption of Ordinance 136-24 in connection therewith. Commissioner Supak seconded the motion. Motion passed unanimously.
- 15. Update on Current Grants -
  - 2020 Grant is for the booster pumps. This one should be good.
  - 2021 Grant is for the Wastewater Treatment Plant drying beds and back-up generator. Matt Breazeale is working on a design scope and descriptive scope. This is due by next Tuesday. Matt stated he could have it to Renee by Friday.
- 16. Mayor Perreault made a motion to approve the financial statements for October 2024. Commissioner Supak seconded the motion. Motion passed unanimously.
- 17. Commissioner Wesbrooks made a motion to approve the payment of bills for October 2024. Commissioner Supak seconded the motion. Motion passed unanimously. Commissioner Supak abstained from check #8388 and #8395.
