1. Call to Order and Announce a Quorum is Present

Commission Supak seconded. Motion passed unanimously. Water and Sewer Budget-Commissioner Supak made motion to move \$4,000.00 from 7250-Sludge Hauling to 7200-Repairs and Maintenance. Commissioner Perreault seconded. Motion passed unanimously
- 17. Discuss and act on payment of bills and transfer of funds. Commissioner Supak made motion to pay bills, transferring \$13,326.12 from General Fund Savings to General Fund Checking and abstaining on checks #6977 and #6983. Commissioner Perreault seconded. Motion passed unanimously.
