## Regular Meeting, January 9, 2018

# 1. Call to Order and Announce a Quorum is Present:

With a quorum of the Commissioners present, Mayor Rod Pavlock called the Regular Meeting of the Orchard City Council to order at 6:00 p.m. on Tuesday, January 9, 2018 in the Council Chambers of the Orchard City Hall, 9714 Kibler, Orchard, Texas.

- **4.** Commissioner Supak made a motion to approve the minutes of December 11, 2017 regular meeting. Commissioner Perreault seconded. Motion passed unanimously.

Commissioner Perrault seconded. Commissioner Supak abstained from check #7343 and #7346. Motion passed unanimously.
