1. Call to Order and Announce a Quorum is Present:
With a quorum of the Commissioners present, Mayor Pro Tem Matt Perrault called the Regular Meeting of the Orchard City Council to order at 6:05 p.m. on Tuesday, October 8, 2019 in the Council Chambers of the Orchard City Hall, 9714 Kibler, Orchard, Texas.

- **4.** Commissioner Supak made a motion to approve the minutes of September 10, 2019 regular meeting. Commissioner Perreault seconded the motion. Motion passed unanimously.
- 5. Commissioner Supak approved the job description for the part time city administrator. The description and application will be online until November 4 2019 and there will be a classified ad in the Wallis News Review until October 31, 2019. No application will be accepted after November 4, 2019 at 2:00. The applications will be reviewed at the November 19, 2019 council meeting and then interviews will be conducted with a potential start date of January 2020.
