AN ORDINANCE AMENDING AN ORDINANCE PASSED AND APPROVED HERETOFORE ON THE TWELFTH DAY OF NOVEMBER, 1975, RESTRICTING TRUCKS OF A CAPACITY GREATER THAN TWO (2) TONS TO OPERATE ON ANY STREET WITHIN THE CITY LIMITS OF ORCHARD, TEXAS, EXCEPT STATE HIGHWAY 36; DECLARING AN EMERGENCY: PROVIDING A PENALTY OF A FINE NOT TO EXCEED \$200.00 FOR THE VIOLA-TION OF SAID ORDINANCE: AND PROVIDING THAT SAID ORDINANCE BECOME EFFECTIVE IMMEDIATELY UPON ITS PASSAGE.

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF ORCHARD, TEXAS:

That Section 2 be amended to read as follows:

Section 2. That it shall not be unlawful for any person:

- a. To operate a truck larger than two (2) tons capacity on State Highway 36 within the corporate limits of the City of Orchard, Texas;
- b. To operate any delivery, emergency, or repair vehicle within the corporate limits of the City of Orchard, Texas, provided such vehicle is not a "Thru Truck", as that term is commonly defined to mean, and provided such vehicle does have a final point of destination within said corporate limits.

II.

If any ordinances or parts thereof heretofore passed and approved by the City of Orchard, Texas, conflict with any of the provisions herein, such prior ordinances or parts thereof are hereby expressly repealed.

III.

The fact that certain repair and emergency vehicles may now be prohibited from operating within the corporate limits of the City of Orchard, Texas, creates an emergency and an imperative public necessity that the customary readings required for approval of such ordinances be suspended, and such rule is hereby suspended, and this ordinance shall take effect and be in force from and after its adoption.
