## ORDINANCE NO. 029-84

AN ORDINANCE AUTHORIZING SHOP KEEPERS; STOREOWNERS AND BUSINESS HOUSES LOCATED WITHIN THE CITY OF ORCHARD; TEXAS TO PROHIBIT SMOKING BY PATRONS IN SAID STORES; SHOPS; OR BUSINESS HOUSES.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ORCHARD, TEXAS:

That the City Council in the public interest and to promote the general welfare of the citizens of Orchard, Texas that any person or business entity that owns either in part or partial controls, operates, or manages a store, shop, or business or commercial house within the City of Orchard may prohibit smoking by all patrons entering such premises if clearly seen signs reads "NO SMOKING IN THIS BUILDING AS PER CITY ORDINANCE NO. 029-84, CITY OF ORCHARD, TEXAS", which must be prominently displayed in or on the business premises.

In the event of a violation of this ordinance, any person may file charges against the offender in the Municipal Court, Orchard, Texas and if found guilty of violating this ordinance, such offender may be charged with a fine of not less than \$10.00 nor more than \$200.00.
