AN ORDINANCE REGULATING THE SIZE OF CULVERTS WHICH MAY BE PLACED ALONGSIDE ALL STREETS, HIGHWAYS, AND ALLEYS WITHIN THE CORPORATE LIMITS OF THE CITY OF ORCHARD, TEXAS.

WHEREAS, in order for drainage culverts to be set and secured by Fort Bend County Maintenance personnel on right-of-ways adjacent to all streets, highways, and alleys within the corporate limits of the City of Orchard, Texas, a requirement by the Fort Bend County Commissioners that such culverts be a minimum of eighteen (18") inches in diameter must be complied with;

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF ORCHARD, TEXAS:

That no person shall place or cause to be placed any culvert contiguous to any street, highway, or alley within the corporate limits of the City of Orchard, Texas, unless such culvert be of at least eighteen (18") inches in diameter.

NOTICE

On the 12<sup>th</sup> day of November, A.D. 19 75, the Board of Commissioners of the City of Orchard, Texas, passed an ordinance, the descriptive caption of which is as follows:
