

ORDINANCE FIXING WATER AND SEWER RATES

THE STATE OF TEXAS :  
COUNTY OF FORT BEND :  
TOWN OF ORCHARD :

WHEREAS, it is hereby officially found and determined that a case of emergency or urgent public necessity exists which requires the holding of the meeting at which this Ordinance is passed, such emergency or urgent public necessity being that the fixing of water and sewer rates is necessary for the efficient operation of the System and in order to provide necessary and urgently needed public improvements for the Town; that said meeting was open to the public as required by law; and that public notice of the time, place and purpose of said meeting was given as required by Vernon's Ann.Civ.St. art. 6252-17, as amended.

THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE TOWN OF ORCHARD, TEXAS:

1. That the monthly water and sewer rates to be charged and collected by the Town of Orchard, Texas, from all customers obtaining service from such Systems of said Town shall be and are hereby fixed as set forth below:

WATER RATES

| First 3,000 Gallons     | \$8.00 Minimum         |
| Next 3,000 Gallons      | .90 per 1,000 gals.    |
| Next 4,000 Gallons      | .80 per 1,000 gals.    |
| Next 4,000 Gallons      | .70 per 1,000 gals.    |
| All over 14,000 Gallons | .65.45 per 1,000 gals. |

✓ Schools - 5 times the above.

SEWER RATES

\$4.000 per month.

✓ Schools - 5 times the above.

2. Non-payment shall result in discontinuance of water and/or sewer service.

3. No free water or sewer service will be permitted.

4. That the Waterworks System will be operated on a fully metered basis.

5. That dual connections (more than one user on a single meter) shall be prohibited.
